#### PRIVACY POLICY

Gio en la Cocina LLC. ("we", "us", "our", or "Geo en la cocina") recognizes the importance of consumer privacy and we take this issue seriously. This Privacy Policy (the "Policy") desribes our privacy practices with respect to the Personal Information (as defined below) collected by our website and mobile application (collectively, the "Services").

This Policy — sets out other important terms regarding your use of the Services — describes how we collect, use, and disclose Personal Information on or through the Services. If you are a California consumer, you may have certain rights under the California Consumer Privacy Act (the "CCPA") and other California laws.

### TYPES OF INFORMATION WE COLLECT

We may collect, and may have collected in the 12 months prior to the date of this Policy, certain Personal Information from you and about you, which may depend upon on your interaction with us. For purposes of this Policy, "Personal Information" is data specifically about you. Personal Information does not include anonymized, aggregated or combined information, which includes data that is related to you but is either identified or studied as a group and anonymized so that it does not identify you specifically. In addition, for purposes of the California Privacy Policy below, Personal Information does not include publicly available information that is lawfully made availble from federal, state or local government records.

We may collect your contact information. We may collect your name, street address, phone number, cell phone number, fax number, and email address. Examples of how this information may be collected include when you register for our Services or use the Facebook Connect feature.

We may collect your payment information. If you make a purchase with us, we collect your payment card information, including your credit or debit card number, expiration date, other financial account details, payment history, and billing address.

We may collect your registration information. We may collect information you use to register for our Services. For example, we may collect your User ID, login name, screen name, nickname, and password.

We may collect information you post or submit, including to social media. We may collect your social media account IDs, profile information, and information you publicly post or submit on social media, such as on Facebook, Twitter and Instagram. In addition, if you use the Facebook Connect feature, we may collect additional information from you, such as your likeness, physical characteristics, profile pictures and live stream feeds, and other information that you post on Facebook.

Gio en la cocina LLC does not knowingly collect personal information from children under the age of 13. If we learn that we have personal information on a child under the age of 13, we will delete that information from our systems. Gio en la cocina LLC encourages parents to go online with their kids. Here are a few tips to help make a child's online experience safer:

Teach kids never to give personal information out, unless supervised by a parent or responsible adult; including name, address, phone, school, etc.

Know the sites your kids are visiting and which sites are appropriate.

Look for website privacy policies. Know how your child's information is treated.

How does Gio en la cocina LLC use the personally identifiable information that has been collected?

We use the information you provide about yourself to complete the transaction for which the information is intended. ### HOW WE COLLECT YOUR INFORMATION

We and our service providers may collect your information in a variety of ways, including: Voluntary Submissions. We collect Personal Information from you when you elect to voluntarily provide it to us. For example, we collect Personal Information when you register and create an account with Gioenlacocina.com ("Member"). The information you provide during the registration process allows to create a unique profile for you on the Services (your "Member Profile"). We also collect Personal Information when you contact us through our Services. We collect Personal Information if you directly request information or assistance from us, inquire about the Services, or send us an e-mail. We also collect Personal Information if you connect via a Social Network API, including Facebook Connect, submit a payment, or complete other online forms. We also collect Personal Information if you add or update information in your Member Profile, invite contacts to join the Services through our e-mail integration feature, or perform people searches through our Who's Searching for You® feature.

Testimonials. We may also provide you with the opportunity to share your reviews, thoughts, or comments regarding your relationship with Gio en la cocina. Such testimonial information may include your personal experiences with our products or services and related Personal Information that you choose to submit through the Services. In the event you elect to do so, we will request your permission before publicly posting any Personal Information contained therein on the Services. Passive Collection. We collect information about users over time when you use the Services. This includes usage and browser information. We may have third parties collect information this way. We automatically collect and store certain information in our server log files each time a user accesses the Services. This information may include computer or device IP address, Internet browser type, Internet Service Provider, referring/exit pages, operating system, date/time stamp, and click stream data. We may collect this information through the use of tracking tools such as cookies and web beacons on our website and in our emails that we send to you:

- Cookies. Cookies are small pieces of data that are based on your Internet activity and stored on the hard drive of your computer by your Internet browser when you visit a website. Through the use of cookies, we are able to collect traffic, usage, and other similar information about your interactions with the Services (such as the time you spent using the Services, the specific portions of the Services that you use or visit, and language preferences), and information about your computer or device that allows us to facilitate your use of the Services (such as to display information more efficiently).
- Web Beacons and Other Tracking Technologies. A web beacon (sometimes referred to as a "pixel tag" or a "clear GIF") is a programming code that can be used to display an image on a website, e-mail, or other communication. Web beacons are typically one-pixel, transparent images and are used to transfer an individual's unique user identification (often in the form of a cookie) to a database in order to associate that individual with previously acquired information about him/her in a database. They allow third parties to obtain information such as the IP address of the computer that accesses the website on which the beacon appears, the URL of that website, the time that the website was viewed, the type of browser used to view such a website, and the information contained in any cookies set by the third party.
